Guidance for families on what to do if ICE (US Immigration and Customs Enforcement) stops you:

General Tips:

Talk to everyone in your home about what to do if ICE officials come to your home or approach you.

- 1. Stay calm.
- 2. Do not run away. Running away gives officials cause to stop and question you.
- 3. Ask to see the official's ID or badge.
- 4. If stopped, ask, "Am I free to leave?" If the answer is "yes," leave. Walk calmly away.
- 5. Show the officer the red card. All people in the United States, regardless of immigration status, have certain rights and protections under the US Constitution. Red cards help people assert their rights and defend themselves in many situations, such as when ICE agents approach them.
- 6. Refuse to answer any questions.
- 7. Refuse to sign any papers.
- 8. Refuse an inspection.
- 9. State that you want to speak with a lawyer.
- 10. Avoid showing any documents with your country of origin.
- 11. Do not lie. Do not show falsified documents.
- 12. Memorize the numbers of two people you can call for help if you are detained, as you likely will not have access to your phone.

Recommended Documents to Carry:

- ✓ Driver's license (any state)
- ✓ Permanent Resident Card
- ✓ US Passport
- ✓ School ID
- ✓ Red card

If You're Undocumented, Do Not Carry:

- **⋈** National ID Card
- **☒** Passport from Home Country
- ☑ Any other document that identifies you as a non-US citizen
- **ID** of another person or any fake documents

At Home:

- 1. DO NOT open the door.
- 2. Pass the officer the red card under the door or show it to them through a window.
- 3. If the officer says they have a judicial warrant, ask them to pass the warrant under the door or show it to you through a window.
- 4. If there is a judicial warrant signed by a judge or magistrate, you must comply. This will have your name, address, and the signature of a judge or magistrate (bottom right corner of document) on it. Make sure they are showing you a SEARCH AND SEIZURE warrant from a DISTRICT COURT and not another type of warrant. (See image below.)

During a Traffic Stop:

- 1. Remain inside your car.
- 2. Place your hands on the wheel.
- 3. Before reaching for your driver's license and car documents, inform the officer you are retrieving them.
- 4. Show driver's license and car documents.
- 5. State that you do not consent to a search.

At Work:

- 1. Remain in a private area.
- 2. Don't leave.
- 3. Follow the plan if your employer has one.
- 4. Your employer should not allow ICE to enter any private area.
- 5. Do not talk to ICE. State, "You are not allowed to enter. Talk to my employer."

Finding and Hiring a Licensed Attorney:

- ✓ Make sure the attorney is licensed and has immigration law experience.
- ✓ Protect yourself from fraud. Only a licensed attorney or Executive Office for Immigration Review (EOIR) and Board of Immigration (BIA) Appeals accredited representatives are authorized and qualified to assist you with immigration status cases. Preparing For If You Are Detained:

If you are detained, a family preparedness plan and Standby Guardian Form will authorize a person that you choose to care for your children. You do not need to go to court to name someone as a standby guardian, and there is no cost to fill out the forms: https://portal.ct.gov/governor/immigration-resources-family-preparedness-plan?language=en_US

Be sure your family members and emergency contacts have a copy of your *a-number*, which is your **alien registration number** found on your immigration documents, if you have one. Family members can use the ICE Detainee Locator to find loved ones: https://locator.ice.gov/odls/#/search.
